## regarding the value of Intrastat thresholds for the collection of statistical information concerning the intra-EU trade in goods in 2024

According to the provisions of Law 422/2006 concerning the organization and functioning of the statistical system of international trade in goods, with further amendments and additions

According to the provisions of Law regarding the organization and activity of official statistics in Romania no. 226/2009 updated with completions and of Government Decision no.957/2005 regarding the organization and activity of the National Institute of Statistics, with the further amendments and additions.

The President of the National Institute of Statistics issues the following

## **DECREE**

- **Art.1.** The following Intrastat value thresholds are approved for the collection of statistical information on intra-EU trade in goods in reference year 2024: 1,000,000 Lei for intra-EU dispatches of goods and 1,000,000 Lei for intra-EU arrivals of goods, respectively.
- **Art.2.** The economic agents who carried out exchanges of goods with the Member States of the European Union during 2023, whose annual value, separately for the two flows, intra-UE dispatches and intra-UE arrivals, respectively, exceeds the value of Intrastat thresholds established for 2023, have to fill in and transmit to the National Institute of Statistics the Intrastat statistical declarations starting from January 2024.
- **Art.3.** During 2024, other economic agents which carry out intra-EU exchanges of goods, whose cumulated value since the beginning of the year exceeds the Intrastat thresholds for 2024, may become Intrastat data providers. These economic agents must complete and submit Intrastat statistical declarations starting from the month in which the cumulative value from the beginning

of 2024 of intra-EU dispatches and/or arrivals exceeds the established Intrastat thresholds, separately for the two flows.

- **Art. 4.** This decree shall be applied by the division of experts involved within the National Institute of Statistics.
- **Art. 5.** The provisions of the Decree of the President of the National Institute of Statistics no. 1493/2022 regarding the establishment of Intrastat thresholds for the collection of statistical information regarding the intra-EU trade with goods in 2023, published in the Official Journal of Romania, Part I, no. 1044 from 28 October 2022, are repealed by the current decree.
- **Art. 6.** This Decree is to be published in the Official Journal of Romania, Part I and enters into force on February 1, 2024.
