

Important changes for Intrastat statistical declaration starting with the reporting month January 2024

➤ **Modified nomenclatures:**

Version 2024 of the **Combined Nomenclature** contains 23 new codes at 8-digit level while 15 codes at 8-digit level were removed from the version 2023 of the CN. Total number of CN codes at 8-digit level is 9769. Combined Nomenclature is available in electronic format on the website www.intrastat.ro.

➤ **Modified Intrastat offline application**

Drafting the Intrastat Declaration for year 2024 will be done using the offline Intrastat Application 2024 version, that we kindly ask you to install on your computer starting with the 1st of February 2024. By installing the 2024 offline Intrastat Application, the 2023 version will be automatically uninstalled, but not the related Intrastat declarations and documentation (guides, manuals, nomenclatures).

ATTENTION! The 2024 offline Intrastat Application has set by default 2023 version of Combined Nomenclature. **THUS**, in order to create declarations for the year 2024 after installing the 2024 offline Intrastat Application, you must upload the new Combined Nomenclature 2024 (CN_2024.xml) by using the "Import" function from the menu "Actions / Nomenclatures" (see chapter 1.3.5 - *Importing a new version of a nomenclature* from the „User Guide for Intrastat offline application 2024” – Version 1).

Please give a special attention to the selection of reference year since the goods nomenclature (CN8 nomenclature), is subject to change, thus making necessary yearly updating in the Intrastat Applications. As a consequence, the 2024 version of Combined Nomenclature differs from those applied in used the previous year.

After installing the 2024 version of the offline application, it is necessary to run the procedure of import of declarations that have been created for 2023 using the 2023 version of Intrastat offline application, in order to be able to visualize / revise them, if necessary. The import procedure can be done using the menu „Declarations administration” (see chapter 1.3.4. - *Importing and saving a previously created declaration*, from the “User guide for offline application 2024” – Version 1).

The Intrastat offline application version 2024 can be also used to create or review Intrastat declaration for 2023.

ATTENTION! to review or create a NEW declaration for 2023, after installing the 2024 version of Intrastat offline application and the import of nomenclatures for 2024, it is necessary to follow the following steps in order to use the nomenclatures in force for 2023:

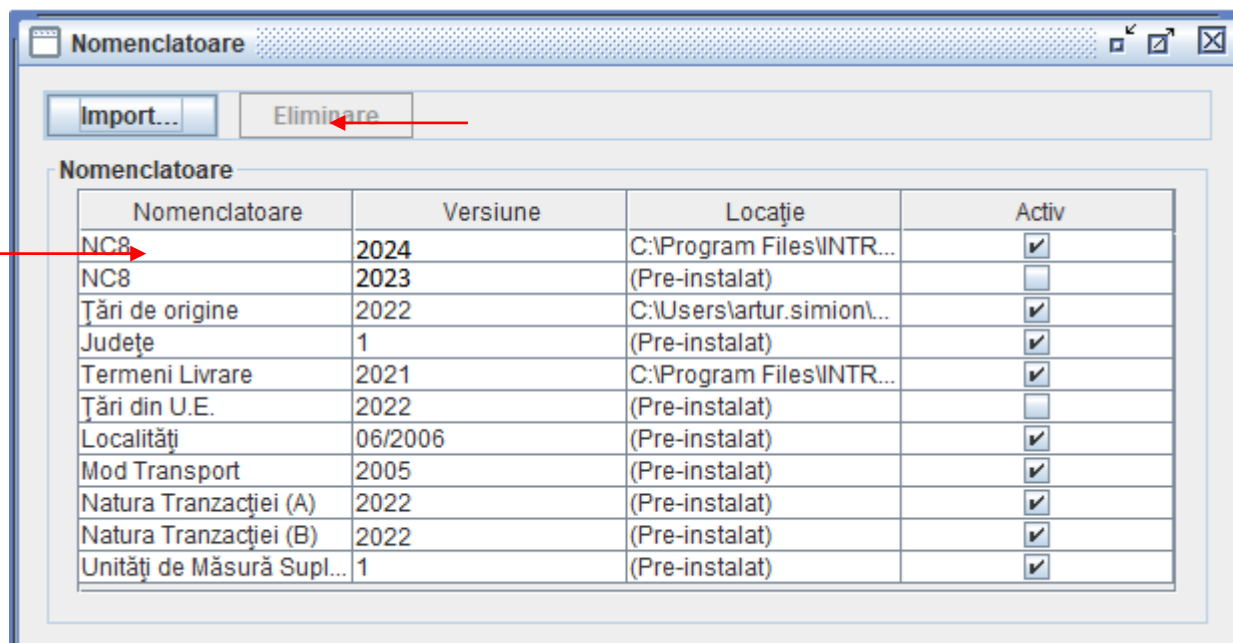


Figure 1. Nomenclatures Administration - eliminate CN version 2024

First step: Eliminate the version 2024 of Combined Nomenclature as follows: in the menu „Actions/Nomenclatures” select the CN8 2024 version, then use the „Eliminate” button from the same window (Figure 1). This step is necessary to activate the CN8 2023 Version.

Step 2: Review or create a „New” Intrastat declaration for 2023 (please pay special attention when selecting the reference period!!!)

Step 3: Return to the 2024 versions of the Combined Nomenclature (to create Intrastat Declarations for 2024)

This will be done through the menu „Actions/Nomenclature”, where “import” button must be used and then select **CN8_2024.xml** file from „Documentation” directory, subdirectory of the working directory. The default working directory is set to C:\Program_files\Intrastat. After running this procedures the 2024 Nomenclature version will be automatically activated.
