

Important changes for Intrastat statistical declaration starting with the reporting month January 2026

➤ **Modified nomenclatures:**

Version 2026 of the **Combined Nomenclature** contains 27 new codes at 8-digit level while 14 codes at 8-digit level were removed from the version 2025 of the CN. Total number of CN codes at 8-digit level is 9797. Combined Nomenclature is available in electronic format on the website www.intrastat.ro.

➤ **Modified Intrastat offline application**

Drafting the Intrastat Declaration for year 2026 will be done using the offline Intrastat Application 2026 version, that we kindly ask you to install on your computer starting with the 1st of February 2026. By installing the 2026 offline Intrastat Application, the 2025 version will be automatically uninstalled, but not the related Intrastat declarations and documentation (guides, manuals, nomenclatures).

ATTENTION! The 2026 offline Intrastat Application has set by default 2025 version of Combined Nomenclature. **THUS**, in order to create declarations for the year 2026 after installing the 2026 offline Intrastat Application, you must upload the new Combined Nomenclature 2026 (CN_2026.xml) by using the "Import" function from the menu "Actions / Nomenclatures" (see chapter 1.3.5 - *Importing a new version of a nomenclature* from the „User Guide for Intrastat offline application 2026” – Version 1).

Please give a special attention to the selection of reference year since the goods nomenclature (CN8 nomenclature), is subject to change, thus making necessary yearly updating in the Intrastat Applications. As a consequence, the 2026 version of Combined Nomenclature differs from those applied in used the previous year.

After installing the 2026 version of the offline application, it is necessary to run the procedure of import of declarations that have been created for 2025 using the 2025 version of Intrastat offline application, in order to be able to visualize / revise them, if necessary. The import procedure can be done using the menu „Declarations administration” (see chapter 1.3.4. - *Importing and saving a previously created declaration*, from the “User guide for offline application 2026” – Version 1).

The Intrastat offline application version 2026 can be also used to create or review Intrastat declaration for 2025.

ATTENTION! to review or create a NEW declaration for 2025, after installing the 2026 version of Intrastat offline application and the import of nomenclatures for 2026, it is necessary to follow the following steps in order to use the nomenclatures in force for 2025:

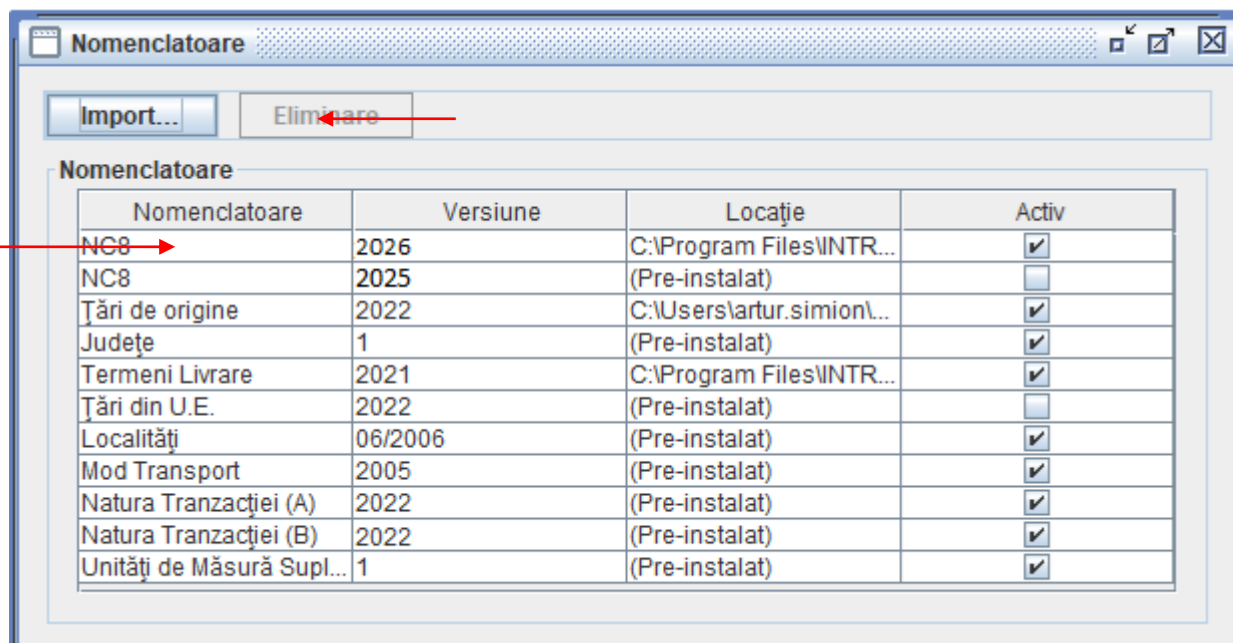


Figure 1. Nomenclatures Administration - eliminate CN version 2026

First step: Eliminate the version 2026 of Combined Nomenclature as follows: in the menu „Actions/Nomenclatures” select the CN8 2026 version, then use the „Eliminate” button from the same window (Figure 1). This step is necessary to activate the CN8 2025 Version.

Step 2: Review or create a „New” Intrastat declaration for 2025 (please pay special attention when selecting the reference period!!!)

Step 3: Return to the 2026 versions of the Combined Nomenclature (to create Intrastat Declarations for 2026)

This will be done through the menu „Actions/Nomenclature”, where “import” button must be used and then select **CN8_2026.xml** file from „Documentation” directory, subdirectory of the working directory. The default working directory is set to *C:\Program Files (x86)\INTRASTAT*. After running this procedures the 2026 Nomenclature version will be automatically activated.
